Summary

- To set up strategic highways company, national, to facilitate later privatisation.
- To set up strategic highways companies, regional, to facilitate later privatisation.
- To create a central government planning, land and buildings control, to facilitate later privatisation.
- To create a central government Land Registry, to facilitate later privatisation.
- To transfer responsibility for local land charges to Central Land Registry, to facilitate later privatisation.
- To create a Home & Communities Agency (HCA) to centralise ownership of properties & land charges. For privatisation.
- To transfer properties & land from local authorities to central government. (HCA) to facilitate later privatisation.
- To set up UK Petroleum company centralised government licensing authority for Fracking oil extraction, to facilitate corporate asset stripping.
- To authorise legal access to Fracking sites with priority planning consent. to facilitate corporate asset stripping
- To free Fracking Corps from liabilities from accidents, pollution or clean up costs. (TTIP)
- Powers of Access to any property for the purpose of; assessment, extinction or removal of Foreign Species.
